- 3) The prices above are based upon prevailing material & fuel supplier prices during week commencing 8th August 2022, but DO INCLUDE already advised tarmac price increases due to come into effect on 1st September 2022. Fortunately fuel prices have come back somewhat from recent record levels in the last month we buy fuel in bulk quantities (>2500 litres), and our most recent price was back down to around 175ppl (considerably lower than what is seen on the local high street pumps!)
- 4) Permission for works to be carried out on the public highway/footway must be obtained from the local highways authority. There is no allowance within the above price for any fees/bonds that may be payable.
